SHORT NOTICE INVITING QUOTATION

Sealed Item Rate quotations are invited from the eligible bidders for the work of "Construction of New District & Sessions Court Complex at Merces, Tiswadi, Goa - Supply and fixing 15 A sockets and switches (2nd Call)". The sealed quotations shall be received upto 15:00 hours on 27th December 2024 and the same will be opened at 15:30 hours on the same day. The estimated cost for the work is Rs.56,425.00.

The Schedule of Quantities including the description of the item is furnished in ANNEXURE-I enclosed herewith. The bidders shall submit their offer by indicating rates for the item as per the enclosed ANNEXURE-I while submitting the quotation. Rates shall be exclusive of GST. All the pages of ANNEXURE-I shall be duly stamped and signed.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to Rs.1,130.00 (Rupees One Thousand One Hundred Thirty only) in the form of Demand Draft from a Nationalised / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at ANNEXURE-II, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.

Bidders in the field of similar work may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only. The last date of issue of bid documents shall be 26th December 2024 upto 15.30 hours.

The security deposit shall be collected by deduction from the bill at the rate of 5% and the Earnest Money deposited will be treated as part of Security Deposit. The Security Deposit shall be released on successful completion of the defect liability period. The security deposit shall be released in full only if all the required maintenance and / or repairs have been carried out by the Contractor in timely manner, to the complete satisfaction of the Engineer. In the event of failure

of the Contractor to properly remedy the defects, the security deposit shall be released with appropriate deduction.

The work shall be completed within 5 days from the date of issue of Work Order / Letter of Acceptance. In case of delay, the successful bidder shall be liable to pay to the employer an amount of Rs.150.00 (Rupees one hundred and fifty only) per day as Compensation for delayed completion for default for every day. However, such total amount as compensation for delayed completion shall not exceed 10% of the original quotation price.

GSIDC reserves the right to accept or reject any or all the quotations in part or full without assigning any reason whatsoever.
